Orders must be reserved by submitting a monthly ordering calendar by the **15th of the month, preceding the month of service.** (Example: To reserve 5 days over Christmas Holidays, order must be received by November 15.) **Plan E** is available on days school is not in session; **Plan F** is available only on days school is dismissed at noon.

**Billing & Payment** - Annual contracts are billed monthly over 10 months (August 2024 - May 2025). XDC Tuition Fees and additional optional days (Plans E and F) are billed through SchoolAdmin/Finalsite.

**Refunds and/or credit** are not given for days missed for any reason.

**Withdrawal** - Billing will be prorated for 30 days after written notification of withdrawal.

**Enrollment Fee** - An enrollment fee of \$100 per family is required. This fee is non-refundable unless we are unable to accommodate your child.
